Topic	Litigation and Arbitration related to alleged breach of contract.
Summary of Issue	HTA Design is an interdisciplinary practice of over 200 architects, urbanists, planners, landscape architects, interior designers, sustainability specialists, graphic designers and researchers with a specialist focus on designing homes and residential neighborhoods. HTA has been involved in litigation and arbitration by their clients relating to breach of contract, relating to cladding on residential towers. The company has settled 2 cases over the past five years through post mediation and commercial settlement.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Each of the aforementioned cases were settled for sums that represented within 5% of the company's total revenues. The company has signed a settlement agreement that is confidential and cannot share the exact settlement amounts.
Impact on Stakeholders	The 2 cases were related to professional negligence pre-action protocol claim disputes between HTA Design and their clients.
Resolution	Each of the aforementioned cases was settled post mediation through a commercial settlement.
Implemented Management Practices	The 2 cases relate to projects undertaken by the business prior to the transfer to HTA Design in 2013, following which comprehensive new processes in relation to project technical reviews, as well as a more robust approach to appointments and design responsibility, all to ensure such matters do not arise again.
