Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Company works or had worked with clients in the following industries: fossil fuels - coal, oil sands; and Genetically Modified Organisms (GMO)
Summary of Issue	Trafalgar Marquees is a British company that provides corporate events support services (i.e. marquees hire). The company earns revenue from clients in the fossil fuels - coal, oil sands; Genetically Modified Organisms (GMO); and Defense industries. The services provided are: supply of marquees for corporate events.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the period from 2018 and 2022, the percentages of the company's revenue generated from services provided to clients in these industries were: 1. Fossil fuels - coal, oil sands: 1% in 2018 and 2019; and 2. GMO: 1.3% in 2022 3. Defense: no revenues between 2018 and 2022 (last time the company worked with this industry was in 2016)
Impact on Stakeholders	B Lab's view is that companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, B Lab's view is that companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards
	will be created to address possible risks related to this matter.
Implemented Management Practices	The company has screening practices in place in order to manage the work with clients on controversial industries: any controversial client has to be screened by the senior management team, and a majority vote is required (3 members of the team) to agree to any engagement with the potential client.
