

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to COVID-19
SUMMARY OF ISSUE	Berghaus experienced 2 rounds of layoffs in the five year period. The most recent being in 2020 due to restructuring as a consequence of COVID-19.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	43 total employees were laid off during the five year period representing approximately 25% of the company's employees during that time period
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	Berghaus provided outplacement resources and enhanced redundancy packages for affected employees. Employees were given a list of vacancies across Pentland Brands. During the remainder of their employment period, the employees received time off for interviews and free access to LinkedIn Learning to support their search for further employment. As part of the collective consultation process, employee representatives were able to submit (if they wanted to) an alternative restructuring proposal to the one that had been presented from consultation groups.
