SUMMARY OF ISSUE	As a brewery, Sawmill Brewery operates in an industry that is water intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 88% of the company's revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDERS	As a water intensive industry, brewing poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.
IMPLEMENTED MGT PRACTICES	<p>Brewing uses on average 3-8 litres of water per litre of beer produced. The company's final product is 95% water. The remaining water is used for cleaning and sterilising.</p> <p>The company takes rainwater from the roof of brewing facility (every litre that falls on the roof is used in beer production) as well as an allocated amount from the aquifer under the property which is accessed via a bore. The water taken from the aquifer is restricted and managed through the applications for consent for a set take by their local Council.</p> <p>This region experiences very dry summers and on occasion drought.</p> <p>The company has a water meter for all water coming into the Brewery with daily monitoring of water use and wastewater generation measures. Sawmill Brewery and have set reduction targets for all water use. they also store all roof water and have The company has implemented efficiency measures such as the use of a centrifuge and optimisation on rinse timers which have reduced the amount of water used. (a centrifuge).</p> <p>The company as well as collecting rainwater to use in the brewery and have optimisation on rinse timers. The company also undergoes CIP audits to identify areas of reduction and is investigating reuse CIP plants with proposed capital expenditure of equipment to make the brewing more efficient (ie larger brewhouse) / specific reduction target of 3.5l / per l of beer produced.</p>
