Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Implemented Management Practices	To mitigate such litigation, the company has now improved some of its internal systems such as the expense reimbursement validations and approvals for employees. There are now regular reviews to ensure compliance with the American Disabilities Act (ADA). The company has also modified the agency contracts to no longer be subject to EU law removing the termination settlement requirement.
