SUMMARY OF ISSUE	General Bio is involved in three ongoing class action lawsuits that involve multiple companies. The first two cases are in relation to reimbursements and the final case is seeking damages related to product. All three are pending final verdict.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Case 1: 1 of 13 companies being sued by the Korea Environmental and Technology Institute. Amount being sought is equivalent to 0.08% of company revenue.  Case 2: 1 of 13 companies being sued by the National Health Insurance Corporation. Amount being sought is equivalent to 0.2% of company revenue.  Case 3: 1 of 20 companies being sued by 330 stakeholders. Amount being sought is between 0.01% and 0.08% of company revenue.
IMPACT ON STAKEHOLDER(S)	Case 3: 4 individual deaths from medical problems related to lung disease with alleged links to humidifier disinfectants.
IMPLEMENTED MGT PRACTICES	The company supervises all purchasing, production, and products such as quality inspection of raw materials and re-inspection of products in cosmetics, food, and household products that are handled from the time of manufacturing and supply of humidifier cleaners to the present. In order to comply with related laws and regulations, in addition to our own technology research centre, as shown in the organization products, the purchasing team and the quality managing team conduct transactions after evaluating the technology and product level of the outsourcer.
OTHER MANAGEMENT COMMENTS	Our sales product, "Humidifier Cleaner", is a product that was delivered and sold using non-toxic raw materials in 2009, and in 2010. The "Korea Accreditation Organization (KOSAS)It is a product that has passed certification in accordance with the Annex to the safety standards for self-safety verification in the field that has been accredited by the company, and passed the hazardous ingredient test through the voluntary safety inspection (KC) in accordance with the Quality Management and Public Product Safety Management Act.

SUMMARY OF ISSUE	General Bio has a subsidiary called GCOOP that operates a multi level marketing business model. GCOOP has operations in Korea, Taiwan, Japan, Vietnam, Malaysia, Indonesia and the United States.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Revenues from this entity account for 80.83% of the overall company revenue. The company has over 30,000 consultant members.



IMPACT ON STAKEHOLDER(S)	The company tracks the profit and loss of their consultants and states that 8.1% of their 30,000 consultants gain a profit over the average earnings and the remaining 91.9% earn less than the average US\$744 per year.
IMPLEMENTED MGT PRACTICES	The company operates a multi level marketing business model that offers free membership. The company is a member of the Korea Special Sales Financial Administration (KOSSA), an organization that protects consumers from fraud or illegal schemes. GCOOP Is the distribution arm of the parent company and B Corp General Bio. Employees are not required to pre purchase stock and there is a hierarchy of five tiers for members - beginner, member, GBO, 1 star and 2 star. Member bonuses are linked to end product sold by their recruits. Members earn commission of 15% on the sales of their tier 1 recruits, 10% on the sales of their tier 2 recruits and 5% on the sales of their tier 3 recruits.
