- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company sells jewelry with precious metals and precious stones
SUMMARY OF ISSUE	E.C. One is a jewelry producer whose products utilize precious metals and gemstones raw materials that could be considered conflict minerals and pose a potential human rights risk.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Within the suppliers expenses, it is recorded that 44% of spending on raw materials corresponds to precious metals, of which 95% are recycled metals (supplied by Heimerle Meule Group, Baird &Co and Euro Mounts & Findings). From these recycled metals, 96% are RJC and 90% Fairtrade certified.
	100% of the companies precious gemstones are from suppliers that provide written assurances of not being sourced from conflict zones. As for their diamonds, 4% are lab grown and 96% follow the Kimberly Process.
IMPACT ON STAKEHOLDERS	The use of precious metals and gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
IMPLEMENTED MGT PRACTICES	The company gives priority to sourcing their raw materials from certified suppliers, including Fairtrade and Responsible Jewellery Council (RJC). Suppliers not certified by other bodies are required to provide written warranties guaranteeing that their materials are not sourced from conflict zones.
	The compnay also has an internal policy for colored gemstones, which includes working with dealers that visit and audit cutters and brokers, and keeping the number of links in the chain as low as possible. The company also notes that unfortunately it is not possible to guarantee full traceability for gemstones.
