TOPIC	One recall of LG batteries due to the risk of thermal runaway
SUMMARY OF ISSUE	Shaw Solar has had one recall of 10 units of LG batteries on August 4th, 2021, the recall was made by their supplier (LG) on the product of LG CHEM "RESU10H - Lithium-Ion residential storage system. The products were recalled due to detected a potential thermal runaway which brings a potential risk of overheating & emission of harmful smoke. 10 units were recalled by the company with a total value of \$84,375, which represented 2% of revenue.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	10 units of the product were recalled that representing 2% of the revenue in the reporting period. No injuries/illnesses were reported.
IMPACT ON STAKEHOLDERS	10 units of the product were recalled that representing 2% of the revenue in the reporting period. No injuries/illnesses were reported.
IMPLEMENTED MGT PRACTICES	The company contacted 10 of the affected clients and provide them replace units without extra charges. 4 out of 10 have been replaced currently, due to lack of stocks. The company expected to continue on replacement starting on Q1, 2022. Besides that, the company have put a halt on the sales of LG CHEM battery.
