

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Significant layoffs due to business restructure
SUMMARY OF ISSUE	Company is a PR and communications agency. Kindred Agency has focused their positioning and core offer around creative PR and communications, rather than integrated communications. As a result, they had to make greater than 20% headcount reduction prior to the pandemic.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	12 employees were laid off, representing 24% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company ran through a robust consultation process with the affected employees, so they can fully understand why roles were at risk of redundancy and to provide them with the opportunity to look at alternative options. At the completion of this consultation process, unfortunately, it happened to be the period of full lock down and there was a very different jobs market. So, in response to this unexpected event, the company extended their employees' notice periods and utilized every available support so the employees could have as much time as possible to seek alternative employment. In terms of assisting employees further, the company looked out and supported them in finding alternative roles by providing recommendations and references. All of these affected employees were able to find alternative roles.
RELATED INCIDENTS	Last March 2022, the company did the restructure of the advertising team which concluded with the formal closure of this team - 4 employees were laid off, representing 10% of company's employees at that time. All of the team members understood the rationale and were provided also with enhanced packages and consultation.
