



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a manufacturing company, Aluproff operates in an industry in which energy and carbon emissions is a material environmental issue.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of revenue comes from the sale of curtain rail & accessories
IMPACT ON STAKEHOLDERS	The manufacturing industry is a major contributor to global carbon emissions.
IMPLEMENTED MGT PRACTICES	The rails are typically delivered in 6-meter lengths, after which the company cuts them to size, processes them, and assembles various components, made and tailored to order before sent out to the customers (B2B). In the company's facilities in Brøndby, the company uses district heating as a primary energy source. Goods from suppliers are transported by sea freight (from the East) or by truck. Only in some limited cases by air freight. In scope 1 and 2, energy consumption, district heating and the transport of goods (upstream and downstream) are the main contributors to the company's carbon footprint. The company has implemented the following measures to optimize its direct footprint: - Installed timers/sensors on lighting in the warehouse. - Invested in an electric van, used to deliver goods to customers in Copenhagen and the surrounding area. - Set up charging stations for electric cars in the company's car park for employees and guests. - Established a collaboration with Goodwings, with a view to achieve "Net Zero Travel" in relation to employee travel.
