Topic	Clients in Controversial and Ineligible Industries
Summary of Issue	Afianzadora has clients in the following industries: Pharmaceuticals, Mining, Fossil fuel, Gambling and Defense.
	The types of services/products offered to these clients include: - Insurance products and services
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 8% of the company's annual revenue was from clients in fossil fuels, 2.5% from gambling 2.6% from mining, and 1.9% from pharmaceuticals.
Impact on Stakeholder(s)	Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	Companies offering certain types of services and products to controversial clients are required to have at minimum a grievance/complaints mechanism and a whistleblower protection policy.
Implemented Management Practices	Afianzadora has the following mechanisms in place to manage the risks associated to serving clients in the mining industry:
	Grivance/complaints mechanism. This is acessible to employees, customers, suppliers and other interested parties through email (reclamos@afianzadora.com.ar), online form and physical compliant mailbox at the office.
	Whistleblower Protection Policy. The policy includes the following statements:  - The company is committed to ensuring that there will be no retaliation against anyone who makes a good-faith complaint, regardless of its nature. This includes protections against termination, discipline, harassment, or any form of employment



	or personal retaliation. Any attempt at retaliation will be investigated and, if found, will result in disciplinary action.  - The company ensures that the identity of the complainant and the details of the claim will be handled confidentially throughout the process. The information will only be shared with the necessary people to investigate and resolve the claim.  - Only the claims team will have access to sensitive information and will ensure that claim data is used exclusively for resolution purposes.  - This grievance mechanism covers, among others, the following types of situations: Violations of labor rights (discrimination, harassment, non-payment of wages, etc.), Irregularities in business practices (fraud, corruption, conflict of interest), Non-compliance with internal regulations (violation of company policies), Quality or service problems (defective products, non-compliance with agreements), and Violation of the law or ethical principles (fraud, environmental damage, illegal practices).  - The investigation period may vary depending on the nature and complexity of the claim, but the company undertakes to complete the investigation within a maximum period of 30 business days.
