Topic	Corporate Shell registered in the British Virgin Islands
Summary of Issue	TASO hospitality group is owned by TASO Holdings Inc, an entity registered in the British Virgin Islands (BVI). All of the group's employees and operations are located in Panamá and Costa Rica.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>The Entity located in the British Virgin Islands was created for overseas shareholders to facilitate and centralize operations, as well as to simplify investments without impacting operations. Additionally, the entity in BVI does not pay taxes on dividends, avoiding double taxation when paying shareholders. The entity does not generate income.</p> <p>Companies in the tourism and hospitality sector in Panamá are eligible to tax exemption for corporate income tax, commercial license, and property tax for a set number of years (between 5 to 20 years) according to Law n° 80 of 2012 (tourism fiscal incentives), therefore the amount of taxes paid for the entities operating in Panamá in the last fiscal year is 0%.</p> <p>The entity located in Costa Rica pays 30% of corporate income tax.</p> <p>TASO Holdings Inc. complies with the current tax laws in Panamá, Costa Rica, and the British Virgin Islands.</p>
Impact on Stakeholder(s)	In addition to the many different aspects of value that business provides society, business has an obligation to contribute its share of taxes. This is because business exists within the context of society; its proper role is to serve society, not the other way around. Moreover, healthy businesses can only exist over the long term in a healthy society. A healthy society depends upon public expenditures made possible by taxes.
Implemented Management Practices	All revenue generated is declared exclusively in the country where said revenue and expense is generated. Each jurisdiction wholly reflects the real economic activity of the entities operations. Consequently, the use of an entity in the British Virgin Islands



	<p>does not affect the corresponding taxes in Panama or Costa Rica; it simply provides an efficient and internationally recognized corporate vehicle for the group's shareholding consolidation.</p>
Management Comments	<p><i>TASO Holdings Inc. is incorporated in the British Virgin Islands (BVI) as a neutral, non-operating holding company to support long-term governance of a multicountry hospitality group. All hotel operations, employees, environmental impact, and community engagement occur at the subsidiary level in Panama and Costa Rica, where TASO remains fully subject to local tax, labor, and environmental regulations.</i></p> <p><i>The BVI entity exists solely to provide a stable and internationally recognized governance framework, allowing consistent board oversight, shareholder alignment, and capital allocation across jurisdictions without favoring one national legal system. This structure simplifies cross-border ownership and supports the attraction of patient, mission-aligned capital, while preserving transparency and accountability where impacts occur.</i></p> <p><i>The BVI structure does not shift operational obligations and is designed to strengthen long-term stewardship, not to reduce local responsibilities.</i></p>
