Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Sharp is an advertising agency that has provided advertising and marketing services to companies in the Fossil fuel (excluding coal, oil sands) and Pharmaceutical industries on an ongoing basis over the past 5 years. The service provided for the client in the Fossil Fuel industry was in relation to the client's renewable energy services, to encourage customers to switch to renewable energy. The service to the client in the Pharmaceutical industry was in relation to the company's biologic therapies to treat major conditions such as Cancer and Alzheimers. The Sharp Agency's offering can be sold to both customers in controversial as well as non-controversial industries and is tailored to the customer's needs.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, Sharp Agency had 0% of revenue from clients in the Fossil Fuel industry and 8% on average in the previous 4 years. The company does not currently work with clients from this industry. Clients in the Pharmaceutical industry represented 38% of the company's revenue in the last fiscal year.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not currently have a position statement on working with clients in sensitive industries. All potential new clients are researched and the company's board discusses and decides if The Sharp Agency will work with certain industries and claims to not work with companies that cause harm such as the gambling and tobacco industries. The company has rejected opportunities to work with a vaping company and a
