



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Clients in controversial industries
TOPIC	Company has clients in the gambling and alcohol industry
SUMMARY OF ISSUE	Koos Service Design is a strategic design agency that developed a digital app for a lottery agency, which is part of the gambling industry, considered controversial by B Lab. Additionally, the company developed the design and prototype parts of a new circular system for beer bottles. The alcohol industry is also considered controversial.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 9% of Koos Service Design's revenue was earned from the gambling industry and 3.6% from the alcohol industry.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact on stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	• The company has created an ethical committee to analyze potential clients to ensure that they don't work with clients who have a negative impact, • Koos's Ethical Commission determined in December 2021 that the company will not sign up new clients from the gambling industry, • The company stated having taken a position on working as little as possible with clients from (amongst others) the alcohol industry and other potentially sensitive industries, • According to the company's roadmap, in 2025 the company will only work on projects (and clients) that are 100% committed to positive impact.
