



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	"Pixza is a pizzeria that earns a material amount of revenue from the sale of alcohol. The company sells artisanal beer."
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	"In the previous fiscal year, approximately 4-4.5% of Pixza's revenue was earned from the sale of alcohol.
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities.
IMPLEMENTED MGT PRACTICES	"Pixza has all necessary permits for the sale of alcohol and complies with all regulations. The company operates with low consumption alcohol, that is, less than 8% alcohol. The company's sale of alcohol is low consumption, so there are only processes for age validation and serving the product. Sales to minors are not allowed. Pixza's sale of alcoholic beverages is low consumption to mitigate risks, that is, the company does not sell prepared beverages of higher degrees of alcohol or in large quantities."
