Topic	Clients in Controversial Industries
Summary of Issue	Creative Energies is a solar energy solutions provider that has served clients in the Fossil Fuels (other than coal, oil sands) industry as well as the Zoos Aquarium, animal parks industry and Defense industry over the last 5 years. Services offered by the company can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Services offered to the Fossil Fuel client was a one-off engagement in 2022 representing 0.4% of the company's FY2022 revenue.  Revenue from clients in the Zoos, aquariums and animal parks industry represented 0.8% of the company's FY2022 revenue.  Revenue from clients in the Defense sector was from a one-off engagement representing 13% of the company's FY2020 revenue. The company no longer works for this client.
Impact on Stakeholder(s)	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.  B Lab has flagged the involvement of companies with clients in
	controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Creative Energies does not currently have a policy to restrict their work from specific industries. The company also indicates that they have not been approached by a potential client that has caused sufficient concern requiring them to initiate a screening process.
