Disclosure Questionnaire Category: Tax Reduction Through Corporate Structure

Topic	Corporate Shell registered in the Virgin British Islands
Summary of Issue	Hikko is registered in the Virgin British Islands, while its operating subsidiaries are based in Uruguay and the United States.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY22, the effective tax rate for the company was 0%. Uruguay has a tax exemption policy applicable to software development companies. The subsidiary based in the United States invoices services exclusively to the other subsidiary of the group in Uruguay, its operating result is at a break-even point.
Impact on Stakeholders	In addition to the many different aspects of value that business provides society, business has an obligation to contribute its share of taxes. This is because business exists within the context of society; its proper role is to serve society, not the other way around. Moreover, healthy businesses can only exist over the long term in a healthy society. A healthy society depends upon public expenditures made possible by taxes.
Implemented Management Practices	All Hikko's staff, revenue and profits are reported at the level of its subsidiaries. The American subsidiary was originally conceived to contract services in Latam and market them to clients in the USA. In 2022, it was temporarily decided to bill exclusively the subsidiary in Uruguay until the necessary administrative infrastructure was in place to bill end customers in the US. This began to be implemented in the current year, 2023. The company expects its tax rate in the US to be 21% by 2026.
