- 1) Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process

Topic	The company sells hemp-based products
Summary of Issue	Phyto-Therapy manufactures and supplies organic powder ingredients. One of the company's product is Hemp Protein Powder (PhytoHemp™) which is made out of hemp seeds. The protein is suitable for human consumption.  The company is not involved in the sale of medicinal or
	recreational marijuana products.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	0.2% of the company's revenue comes from the sales of Hemp Protein.
Impact on Stakeholders	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	All of the Phyto-Therapy products comply with applicable laws and regulations in Australia.  Hemp or industrial hemp is defined as a cannabis plant that contains 0.3% or less THC, which is different to marijuana. Under Food Standards in Australia, low-THC hemp is considered a food.  As part of the company's supplier quality control program, suppliers are required to test the total THC level of hemp seeds and hemp protein as per specification. The company had also conducted continued testing of the Total THC level in hemp protein powder at the beginning, working with the supplier; based on satisfactory results, the company decided batch testing is no longer required.
