Summary of Issue	SISTEMAS TELEMATICOS SISTEL SAS offers corporate virtual training services to companies in Pharmaceutical, Fossil Fuel (coal, oil sands) and Whole Life Insurance industries. The company has served clients in these industries on an ongoing basis over the last 5 years.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	From the company's FY2022 annual revenue: - Clients operating in the Pharmaceutical industry represented 19.1% - Clients operating in the Fossil Fuels (coal, oil sands) industry represented 4.1% - Clients operating in the Fossil Fuels (other) industry represented 0.46% - Clients operating in the Whole Life Insurance industry represented 1.4%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
