Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- 1) Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Topic	Litigation and Arbitration related to wages and hours disputes, unsafe work conditions, discrimination, wrongful termination & ADA complaints.
Summary of Issue	"Between 2019 and 2023, a class action complaint was filed by workers against Room & Board in California. The class action alleged wage and hour disputes, as well as reimbursements and unlawful competition.
	In 2023, Colorado employees filed an unsafe working condition claim with the Department of Labor (CDLE) due to not providing paid sick leave for individuals to obtain COVID-19 Vaccinations
	In the last 5 years, Room & Board reported having 7 other material cases alleging the following: • 2 ADA complaints • 4 discrimination cases • 1 wrongful termination
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The overall amount paid by Room & Board represents less than 1% of the company's revenue.
Impact on Stakeholders	The primary stakeholders impacted were former and current employees, as well as consumers.
Resolution	All cases have been settled with payment by the company
Management Practices	The company has included additional communication about sick leave to staff and leaders on their intranet. The company has implemented closed captions on its website content. The company updated its job postings, removing language stating that they conduct background checks. No practices were implemented related to the class action.
