SUMMARY OF ISSUE	Phyto-Therapy Pty Ltd has had 1 recall in the last five years due to customer reporting gastrointestinal distress.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Customer reporting gastrointestinal distress, all symptoms subsided after ceasing consuming the product. All products in SOH of Customer recalled across 3 x batches with a total cost of \$120,000 AUD. (This was covered under insurance.) Amount to <1% of annual revenue.
IMPACT ON STAKEHOLDERS	10 customers reported the symptoms
RESOLUTION	Recalled products
IMPLEMENTED MGT PRACTICES	The company conducts a complete microbiological analysis of every product manufactured as per Food Safety Regulations. The Staphylococcus aureus was tested and not detected. However, it was discovered that S. aureus was present in the starting Raw Material and produced an enterotoxin. During manufacturing, the bacteria were killed. However, the enterotoxin remained in the finished product causing the symptoms. Phyto now conducts additional testing on the material, including testing for the enterotoxin on every batch of raw material.
