Issue Date	Ongoing
Topic	Labor litigation related to absences, disciplinary measures, fixed-term contract termination, and dismissal claims
Summary of Issue	Labor suits involve a range of actions filed by employees, primarily concerning claims for back wages, compensation for wrongful termination, and demands for damages and loss of income.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	There were 4 labor suits filed against the company that required a disclosure. 3 cases are closed with the following settlement amounts: CLP \$630,000, \$1,000,000, \$5,000,000. All cases represented less than 1% of company revenue. 1 case is currently pending. No financial value is associated with this case at this time.
Impact on Stakeholder(s)	Four individual employees were directly impacted. The primary impact of these legal issues is financial.
Resolution	Three cases were resolved through conciliation agreements with payments, duly homologated in court and closed. One case is still pending.
Implemented Management Practices	To prevent future occurrences of similar issues, the company has implemented the following practices: > HR Policies: The Human Resources department has established clear policies and procedures for handling worker requests and addressing sick leave. It has also improved its control and monitoring of employees with suspensions and is holding capacity-building sessions for team leaders. > Internal Regulations: The Human Resources department has established new internal regulations with clear policies and disciplinary sanctions to prevent future disputes related to worker misconduct. Capacity-building sessions for team leaders are also being conducted.

	> Contractual Transparency: The company is now ensuring that legal standards for fixed-term contracts are met. The HR department is communicating personal data and terms and conditions of these contracts more transparently. > Conciliation Efforts: The company is making every effort to reach a conciliation agreement in the early stages of disputes to avoid lengthy and costly legal battles. However, the company is prepared to proceed to court when a fair agreement cannot be reached.
