

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company sources clay from mines
SUMMARY OF ISSUE	East Fork Pottery LLC's main product is clay objects and dinnerware. Companies that purchase mineral resources such as clay have a higher risk of encountering social and environmental issues in their supply chain, such as water and energy intensive practices, pollution, loss of biodiversity and human rights violations.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	90% of the clay used by East Fork Pottery LLC comes from small mines in the southeastern US within 400 miles of East Fork Pottery LLC's location in Asheville, NC. Less than 1% of materials, the coloring minerals in glazes, are purchased through a third party vendor and without source information.
IMPACT ON STAKEHOLDERS	The impact of mining and extractive operations would be with the communities and the ecosystems where the company's suppliers are situated, should their control & risk management systems fail and result in some negative social and environmental impact.
IMPLEMENTED MGT PRACTICES	East Fork Pottery has published some information online about where clay is sourced in the region. The company has a supplier code of conduct but, currently, does not perform any audits on social and environmental standards for suppliers.
