

## **DISCLOSURE MATERIALS**

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

TOPIC	Company sells alcohol products
SUMMARY OF ISSUE	Mana Earthly Paradise is an eco-resort with a probiotic restaurant at the Villa named Mana Kitchen, that earns a material amount of reveue from the sale of alcohol (beer, wine, and local alcohol called 'arak').
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 5% of MANA EARTHLY PARADISE's revenue was earned from the sale of alcohol, (IDR 32 million out of the total IDR 642 million)
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	"Mana complies with all relevant regulations and laws pertaining to the sale of alcohol in Indonesia. Mana Kitchen sells beer, wine, and local alcohol called 'arak'. The sale of hard liquor (eg. whisky, vodka) with an alcohol content above 20% require a specific license; Mana is currently applying for this license to begin the sale of hard liquor. In general, enforcement of the official drinking age (21 years) is not common in Indonesia, e.g. checking identification at bars and restaurants is very rare. Nevertheless, Mana Earthly Paradise service staff are trained to ensure that if a customer that appears to be a minor orders an alcoholic drink, then the customer will be asked to show an ID. For the company's in-house guests, a copy of their ID is taken upon check-in, so the service staff can cross check if there is any doubt.  With regards to over-serving alcohol, the service staff are trained to make note of any customers who appear to be inebriated or misbehaving due to alcohol consumption. Service staff will report the case to the manager in charge, who will in turn communicate with the customer about any further consumption. In the worst case, the Mana security team and pecalang (village-level security officers) get involved in handling such cases. Mana Kitchen also closes at 9pm everyday to minimize potential misbehavior by overconsumption of alcohol by customers as well as to make sure Mana contributes to a peaceful environment for the surrounding local villages.
MANAGEMENT COMMENTS	Mana also sources alcohol from local vendors, contributing to the local economy while reducing carbon footprint. Even the coctails at Mana are health-conscious; they are made with local organic ingredients with traditional herbs.
