



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Jeni's Splendid Ice Creams is an ice cream manufacturer that sources its milk from dairy Farms.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the 2021 reporting fiscal year, 95% of company revenues came from animal/dairy farms.
IMPACT ON STAKEHOLDERS	B Corp and Jeni's believe that products from pasture-raised animals are healthier than those from animals provided an exclusively grain diet. Animals raised without access to pasture produce less nutrient rich milk, and products derived from that milk tend to provide less vitamin E, beta carotene, conjugated linoleic acid (CLA) and omega-3 fatty acids.
IMPLEMENTED MGT PRACTICES	<p>Implemented MGT Practices</p> <p>Jeni's uses both the National Dairy F.A.R.M program standards (https://nationaldairyfarm.com/what-is-farm/) and its own Pasture-Based Milk Sourcing Audit standards to drive best practices and ensure compliance by farms from which Jeni's sources milk. The farms who provide milk to Jeni's partner producers are all family owned. Jeni's audit standards focus on five areas:</p> <ol style="list-style-type: none">1. Animal Care2. Antibiotic Stewardship3. Biosecurity4. Environmental Stewardship5. Workforce Development <p>Jeni's Quality and Sourcing teams specify that farms from which milk is sourced shall adhere to the standards noted, and annually audit at least 10% of the farms who provide milk to Jeni's partner producers.</p>
