



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	April 2020
TOPIC	On-the-job fatality due to COVID while on assignment (QIDA is a homecare service company)
SUMMARY OF ISSUE	Employee worked as one of the caregivers of QIDA who was on assignment for homecare. At the time in March 2020, the Catalan government asked for caregivers to man nursing homes. It was at the height of COVID-19 when the incident happened, and one of the caregivers deployed by QIDA was affected. The accident did not occur on the company's premises. We cannot prove that the employee was infected at work. The employee started work on 03/26/2022. The company informed the employee of the risks and gave him the necessary training and material in relation to the prevention of occupational risks (masks, gloves, gel and uniform). On 04/01/2022 the employee received medical leave and did not return to work. On 04/02/2022 the employee was admitted to the hospital and on 04/17/2022 he died.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Only 1 employee was affected in the past 5 years
IMPACT ON STAKEHOLDERS	Employee fatality
IMPLEMENTED MGT PRACTICES	To avoid the situation from happening again, the company reinforced new COVID protocols (in accordance to the number of waves experienced in Spain). Include precautions with caregiver assignments, coverage of leaves, hazard pay, healthcare coverages, PPE recommendations to families, family counselling, among other measures to support workers. QIDA supported the bereaved family by handling the administrative work, payroll, and settlement.
