Summary of Issue	Verve is a company that provides branding and events solutions to clients in controversial industries such as alcohol and pharmaceutical industries. The same event management and creative services are provided to clients in non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	39% of the client revenue has been from clients in the alcohol industry. 0.2% of the client revenue has been from clients in the pharmaceutical industry. The company worked ongoing with clients in the alcohol industry in the last five years. The company worked occasionally with clients in the pharmaceutical industry in the last five years.
Impact on Stakeholders	Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries.
Implemented Management Practices	The company's engagement in these sectors involves active collaboration with clients on Environmental, Social, and Governance (ESG) initiatives. The company engages in discussions with their clients, emphasizing sustainability efforts such as waste reduction and repurposing existing items to minimize environmental impact. They are also advocates for non-alcohol alternatives and increased awareness of such choices for clients in that industry. When partnering with clients, the company seeks to understand their ESG policies and priorities, effectively aligning their services to support these objectives. The company maintains a policy of not engaging with clients from specific industries, including gambling, prisons, firearms,



	mining, cannabis-related products, and child labor or orphanage programs. The company employs a custom-built event carbon calculator to identify opportunities for reducing carbon emissions during service delivery and aims to achieve carbon-neutral events by 2024. Additionally, they participate in sustainability councils like AdNet Zero, encouraging their clients to join these initiatives. Ad Net Zero focuses on decarbonizing advertising production, distribution, and publication.
