Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- 2) Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Summary of Issue	Androscoggin Bank has clients in the following industries: Defense and/or Offensive Firearms and Mining.
	The types of services offered to these clients include: • Banking services, including deposits and loans.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 2% of the company's annual revenue was from clients in the Defense industry and 1% from clients in the Mining industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. Companies offering certain types of services and products to controversial clients are required to have at a minimum a grievance/complaints mechanism and a whistleblower protection policy.
Implemented Management Practices	Androscoggin Bank has the following mechanisms in place to manage the risks associated with serving clients in the controversial industries: Grievance/complaints mechanism. This is accessible to the public through a Complaint & Grievance Reporting Policy available on the Bank's website, which includes all the available channels to raise a grievance. All external stakeholder complaints will be: • Reviewed promptly, responded to and resolved or escalated within seven (7) Business Days. • Kept confidential to the extent possible. • Investigated impartially by appropriate personnel in a timely manner. • Documented and tracked for reasonable progress. • Given appropriate options for remedial action and resolution.



If the complainant does not agree with the resolution or the issue is still unresolved after seven business days, the complaint will escalate to the Chief Administrative Officer. The decision made by the Chief Administrative Officer shall be final.

Whistleblower Protection Policy. The Policy includes the company's commitment to protecting whistleblowers from retaliation. Any employee determined by Androscoggin Bank to be responsible for harassment, discrimination, retaliation, or other prohibited conduct will be subject to appropriate disciplinary action, up to, and including termination. The Bank commits to the protection and safekeeping of both company business information and customer accounts, and shall abide by all applicable federal and state regulations. This commitment includes managing the risks of fraud, dishonesty, and the maintenance of confidential and proprietary information. Employees are encouraged to report concerns regarding suspected wrongdoing or misconduct.

This approach is subject to periodic review to ensure effectiveness and compliance with applicable laws and best practices. Androscoggin Bank reserves the right to update as necessary.
