SUMMARY OF ISSUE	As a vineyard and winery, Tiraki operates in an industry in which biodiversity impact and monoculture agriculture are material environmental issues.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% of Tiraki's revenue was earned from the sale of wine. The company does not control land for cultivation, but rather buys grapes from a sole supplier, Longfield Farm. Longfield Farm controls 763 Hectares of land, 210 Hectares of which is a vineyard with the remainder being farmed for cattle, sheep, and crops.
IMPACT ON STAKEHOLDERS	Agriculture, particularly in cases where a single crop is cultivated at a time, poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
IMPLEMENTED MGT PRACTICES	Although Tiraki does not control the land where the grapes are grown, the company has direct involvement in how the Farm is run, encouraging more native plantings, and maintaining planting cover crops and sheep grazing in the vineyards. Tiraki makes donations to organizations that work to preserve biodiversities such as the Picton Dawn Chorus and the Friends of Rotoiti. The company plants cover crops in autumn and spring down the vineyard rows and native plantings along their waterways to help attract native wildlife and increase biodiversity. The company mentions that, among the benefits of cover crops, the combination of the native plantings on the property and the cover crops that they use encourage beneficial insects and soil diversity with valuable microbial life. Tiraki is working towards transitioning its pinot and chardonnay blocks into organic (3-year process) and will maintain to plant cover crops whilst also maintaining its native plantings on the property.
