



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

The first case involves the Instituto de Terapia Intensiva do Tocantins in an alleged breach of contract and the other case alleges that Instituto de Terapia Intensiva das America provided services without a contract.

IMPACT ON STAKEHOLDER(S)	The company states that there were no impacts on stakeholders.
IMPLEMENTED MGT PRACTICES	Both companies are pending court approval on both cases and have implemented some changes in management practices in the form of improving their legal support in business operations and in negotiations and contracts through formalisation of processes. Note that the Instituto de Terapia Intensiva das America is not included in the scope of the America's Health B Corp Certification.
