Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	Videverde offers organic waste composting services to clients in Fossil Fuels - other; Pharmaceuticals and Animal Products industries. The company has served clients in these industries on an ongoing basis over the last 5 years.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	From the company's FY2023 revenue: - 3% was from clients operating in the Fossil Fuels industry, 7% from clients operating in the Pharmaceutical industry and 1% from clients in the Animal Product industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Currently Videverde does not have any management practices specific to mitigate any potential risk related to the Fossil Fuels, Pharmaceuticals and Animal Products industries.
