Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Company serves clients in Controversial Industries
Summary of Issue	Luxexpo The Box is an events company that hosts events and rents spaces for exhibitions to clients in controversial industries such as alcohol, tax advisory services, and whole life insurance products. Their services can also be sold to non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	For the fiscal year 2023, revenue from clients in controversial industries amounted to less than 1% of the company's total revenue: - 0.18% of the client revenue has been from clients in alcohol industry. - 0.71% of the client revenue has been from clients in the tax advisory services industry. The company did not work with clients in the whole life insurance products industry during 2023; currently is working with this industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have a formal stance on working with clients in controversial industries. When working with clients in the alcohol sector, the company reviews that the client mentions the importance of alcohol being consumed in moderation. Additionally, the company's commercial agreement requires the organizer to ensure compliance with local anti-noise regulations, safety conditions, health and safety provisions, copyright laws, drug legislation, and general legal and public decency requirements.
