Disclosure Questionnaire Category: Environmentally Intensive Industries

Topic	Energy and Emissions Intensive Industries
Summary of Issue	As a company in the food production industry, Gelit Srl operates in an industry that is energy and emissions intensive. Gelit Srl does not currently conduct industry comparison assessments but has measured its carbon footprint and energy intensity.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 100% of the company's revenue was earned from the sale of food products and services. Primary energy/emissions drivers are freezers and industrial heaters. The company's energy intensity in 2022 was (GRI 302-3) GJ/tons produced : 4.46
Impact on Stakeholders	Gelit Srl is a food production facility that uses electricity, GPL and carbon-based fuels to produce frozen food products. The company contributes to global carbon emissions by using electricity as their primary source of energy at their plant.
Implemented Management Practices	In 2021 Gelit Srl bought origin certificates from hydroelectric sources for 100% of power energy consumption. In 2022 Gelit approved investments over 7 million € to install 2,3 MWatt of solar panels + 2 Mwatt of gas-trigenerator. Both plants are located in their facilities and will start operating at the end of 2023. So in 2024, 20% of power energy will come from solar source and Gelit will be 95% independent from the national grid. Gelit has a 2035 Net Zero target and it is part of an Italian coalition called Co2alizione made to gather information within companies to help each other find ways to reduce emissions.
Management Comments	In 2022 Gelit made an assessment of overall corporate LCA by an external qualified society to also measure its total carbon footprint.
