

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

торіс	Company is a marketing agency that has worked with clients in controversial industries.
SUMMARY OF ISSUE	December 19 is a marketing agency based in London, UK, specialized in media planning and buying with a 100% client-centered approach. Paying customers are business clients.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	During 2020, the company worked with: - a company in the energy sector that represented 5.54% of total revenue clients in the alcohol sector whom represent 0.69% from their total sales.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries may contribute to the controversial impact or negative harm of their clients by promoting growth within the industry.
IMPLEMENTED MGT PRACTICES	"The company has only ever worked with one client of non-renewable energy source. Their service was to buy and execute advertising campaigns on their clients' behalf on topics such as: Renewable Energy, Electric Vehicles, BECCS and decarbonisation. Due to delays in their clients' transition plan to stop burning coal at their power plants, December 19 took the decision to cease working with this client.
	They have also worked with luxury alcohol brands with a high price tag and are marketed to be consumed for special occasions, not casual drinking.
	The company charges these clients a flat fee of 15% commission which is the standard for their clients.
	They have started to implement policies for new clients, similarly to how they are now screening new suppliers. They are now formalising this into a process to judge clients based on their business ethics and environmental impact. - They no longer want to work with a business involved in fossil fuels. - They are approaching new client opportunities with an open mind on their values and practices. They feel that the potential of working with them to improve their practices has the potential of a more positive impact in the world.
