

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Other - Production site is located within a preserved and protected ecosystem.
TOPIC	Company production plant is recognised by UNESCO as a World Heritage site.
SUMMARY OF ISSUE	Posidonia is a company that produces and sells low sodium liquid salt sourced from the Formentera Salt Pans. In 1999, UNESCO declared the Formentera Salt pans a UNESCO World Heritage Site. The salt fields are 2600 years old.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The Formentera Salt Pans are 100% owned by the company. 100% of the company revenue comes from the sale of the liquid salt.
IMPACT ON STAKEHOLDERS	UNESCO (a specialized agency of UN aimed at promoting world peace and security through international cooperation in education, arts, sciences and culture) asked the company to open salt fields here as too much salination is bad for nature, so they would need to be utilized or to be produced as salt products. The main process in the sensitive area is the natural evaporation via wind and sun, like classical sea salt.
IMPLEMENTED MGT PRACTICES	The company does not process any of the salt at the Salt Pans. Processes such as filtration and packaging happen at their logistic partner in Tarragona (Barcelona). The company claims that they are strongly committed to the preservation and protection of the salt fields of Formentera. They invest into the renovation of the Salt Pans with the support of local authorities. On a regular basis, independent scientists are evaluating their impact on the biodiversity in Formentera. Different works are implemented each year for the maintenance of the natural park such as the maintenance of the walls of the salt pans, waste collection, didactic panels, raising of the doors to avoid the flooding of the nests of birds.
