



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	"In 2017 and 2019, Ancient Nutrition was the defendant in three cases related to Product Safety. • Cases #1 and 2 -- Plaintiffs brought separate suits against Ancient Nutrition alleging violation of California's Proposition 65 for the undisclosed presence of certain heavy metals in certain of the Company's products. • Case #3 -- A consumer alleged that they had suffered physical harm as a result of prolonged consumption of Ancient Nutrition's dietary supplement products. The suit also alleged that Ancient Nutrition had falsely advertised the health benefits and dangers associated with its products."
"SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)"	All aforementioned cases were settled for a sum >\$100k, but less than 1% of company's FY21 revenue.

RESOLUTION	All aforementioned cases were settled out of court.
MANAGEMENT PRACTICES	All company products undergo heavy metal evaluation and testing to ensure Prop 65 compliance. These initiatives include setting heavy metal specifications that meet Prop 65 disclosure standards, monitoring and testing all products per lot. Product testing performance is reviewed during annual product review process.
