



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	August to October 2020
TOPIC	Significant layoffs due to economic impact on company during Covid-19 pandemic.
SUMMARY OF ISSUE	The company had to cease operations due to COVID restrictions.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	5 employees were laid off, representing 36% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	• The personnel were informed, verbally and in writing, and provided with a full explanation of the reasoning. In addition, the company explained the numbers, job types, the proposed method of selection, the procedure and how redundancy payment would be calculated; • The layoffs were made when there was no other option for the survival of the business; • Other practices conducted were: company sought voluntary redundancies, had at least 2 conversations with each employee whose job was at risk, a scored system was used to determine the employees that would be laid off; each laid off employee had the right to appeal but none chose to.
