



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

IMPLEMENTED MGT PRACTICES	"The company kept the employees on furlough for as long as they legally could do after advising the workers of the redundancy process. They also worked with the employees made redundant to find other employment including interview preparation, introducing them to recruiters and the company clients. The company also shared their Job Seeker Toolkit and also devised a portal to support external businesses (Major Support) where the staff could access a host of content from wellbeing, goal setting, CV's etc. Major Players devised a redundancy matrix which was used by the Managing Director and Commercial Director detailing the considerations that were made before coming to the decision around people affected . The decision was communicated to the staff through face to face consultations and email communication throughout the process. "
