The company's services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	From the company's FY2023 annual revenue: -Clients operating in the Animal Products & Service industry represented 0.045% -Clients operating in the Fossil Fuels - coal, oil sands industry represented 0.22% -Clients operating in the Mining industry represented 0.66% -Clients operating in the Tax Advisory Services industry represented 9.7%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.  B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards
	will be created to address possible risks related to this matter.
