

## **DISCLOSURE MATERIALS**

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Plant People is wholesaler and retailer of hemp derived products and earns a material amount of revenue from the sale of full-spectrum hemp dietary supplements and topical products.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year about 90% of the company's revenue was earned from the sale of products produced from hemp extracted ingredients.
IMPACT ON STAKEHOLDER(S)	Per the 2018 Farm Bill, hemp and hemp derived products are legal in the United States.
IMPLEMENTED MGT PRACTICES	Plant people complies with all relevant federal and state requirements for hemp production and sale, which includes biomass and finished products that are less than 0.3% THC.  The company is not involved in the sale of medicinal or recreational marijuana products. Each hemp based product uses hemp that has <.3% of THC upon dry weight (harvest) and have <.3% THC in the finished good. Most the products have <.2% for extra buffer. The company produce product out of cGMP, FDA, NSF and USDA organic facilities. In addition, the company is compliant with state by state regulation (Louisiana, Utah, Florida etc.).
