Summary of Issue	Sarah Raven's Kitchen and Garden Limited provides a comprehensive range of seeds, seedlings, plants, and gardening and floristry kit. Among their products, the company also sells pesticides and fertilizers.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately, 5.3% of the company's revenue comes from pesticides and fertilizers sales.
Impact on Stakeholders	Agriculture poses a risk to local ecosystems of flora and fauna as well as the potential degradation of cultivated land.
Implemented Management Practices	All fertilizers and pesticides sold by Sarah Raven's Kitchen and Garden are bio-based. The company has a 100% non-GMO ingredients policy.
	The company's environmental policy states that they select and offer fertilisers and pest control products which are made from natural ingredients, are peat free, and harmless to pollinators, garden birds, children and pets. They choose products made from natural ingredients that are safe for the environment, and avoid synthetic fertilisers or chemical-based pest control products.
	In addition to that, for crop protection at the onsite nursery (Rookery Farm), the company measures include weekly report recording water usage, operators, quantity and type of crop protection and equipment used.
