SUMMARY OF ISSUE	As a Controlled Environment Agriculture (CEA) grower, Gotham Greens Holdings operates in an industry that is recognized as being energy intensive.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of Gotham Greens Holdings revenue from the previous fiscal year came from the sale of products grown using CEA.
IMPACT ON STAKEHOLDERS	Controlled Environment Agriculture (CEA) can be energy and carbon intensive due to the potential use of artificial lighting, heating, cooling, and dehumidification to create the ideal environment for plant growth and photosynthesis. Environmental impact is dependent on the energy sources used.
IMPLEMENTED MGT PRACTICES	Gotham Greens Holdings has taken numerous steps to mitigate the energy intensity of their CEA practices. The company surveyed the landscape of CEA applications and selected greenhouse hydroponics as its growing methodology because of its efficient use of energy sources compared to alternative modes of CEA. In this application of CEA, the sun is the primary light source for plant growth and photosynthesis. The company only employs supplemental lighting during winter months in order to augment the natural lighting conditions when days are shorter. Other energy sources used include: a combination of on-site solar, grid electricity, liquid CO2 and natural gas. To reduce the impacts of energy sourced from fossil fuels, the company purchases renewable energy credits to offset 91% of its electricity emissions. Further, their decentralized network of greenhouses reduces emissions from transportation by prioritizing local distribution. In 2020, 77% of distribution occurred within a 50-mile radius from one of their greenhouse facilities. Gotham Greens Holdings also monitors and tracks its energy usage via sensors, controllers, and various meters located on site to optimize its operations and corresponding energy demand. Gotham Greens Holdings has committed to continuously limit energy consumption and improve energy efficiency by researching and investing in new energy efficient technologies for lighting and temperature control. The company benchmarks its resource consumption (such as electricity, water, and gas) throughout the year using data from published reports and/or white papers for other greenhouses around the world, and uses this to adjust internal targets, optimize usage and make roadmaps for achieving required reduction. The company also has formal resource reduction targets to reduce electricity usage by 5% per square foot by the end of 2024 (from 2020 baseline) and to reduce Scope 1 & Scope 2 emissions by 5% per square feet by 2024 (from 2020 baseline).
