



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

DISCLOSURE QUESTIONNAIRE CATEGORY	Facilities located in sensitive ecosystems
TOPIC	Moyee Coffee has operations in sensitive ecosystems.
SUMMARY OF ISSUE	Moyee Coffee acquired land in tropical rainforest in Ethiopia, which can be considered a sensitive ecosystem. The company's goal is to protect part of the area and in the other part develop a reforestation project. To conduct the latter, the company will use agro-forestry practices to replace monoculture production that used to be conducted in the region.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company adopted 240ha of forest to protect and 20ha of deforested land to start a reforestation project.
IMPACT ON STAKEHOLDERS	The facilities/operations are located inside protected/sensitive ecosystems which could potentially impact the flora, fauna and quality of the ecosystem (e.g. noise & light pollution from the facilities, spills, air / soil / water pollution owing to company's operations).
IMPLEMENTED MGT PRACTICES	- The company works with Rainforest Alliance, the German government, and Dutch Government on this reforestation project to show alternatives are valid and it is wise to keep off from primary forest and focus on agroforestry to increase income and increase woman empowerment, - The company has operations in areas where the harvesting of forest products such as coffee is permitted, - Regarding the Model farm & agro forest plots, the company's goal is that there are 45 smallholder farmers have increased ownership of productive resources and increased security of land tenure and usage rights. Additionally, the company intends to reach 6225 ha of land under sustainable agricultural use and 425,000 coffee trees in an agroforestry multispecies system.
