Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Cannabis Related Products

Topic	Company sells a clothing product made from hemp
Summary of Issue	Another tomorrow is an apparel company that sells clothes using sustainable materials and has one product made from organic hemp. The company is not involved in the cultivation or harvesting of hemp directly and are not related to any cannabis derived products that are ingested by humans or used for medical purposes.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	0.006% of the company's revenue is from the sale of the product containing hemp. One unit of this product contains 58% organic hemp.
Impact on Stakeholders	Cannabis-related products are subject to controversy both because of their current and historic legal status around the world, as well as concerns about the potential harm that the products may cause. Current regulations governing the legality of cannabis-derived products are complex and vary widely by local jurisdiction.
Implemented Management Practices	Another Tomorrow is a company registered in New York State that follows and complies with regulations for the sale of cannabis related textile products.
Management Comments	Another Tomorrow uses hemp because it is a naturally low impact fiber. With a number of ecological benefits, hemp is appreciated by farmers as it helps their lands flourish and grow about 10-20% more of their rotational crops. It improves soil health, suppresses weeds, and provides large amounts of pollen making it a valuable source for bees.
