Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process

Summary of Issue	The company is a digital marketing agency that has had clients in the alcohol and fossil fuels industry. The nature of the company's services with clients in these industries has been related to web hosting services and managing social media presence. All services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the alcohol industry represented 0.2% in FY 22-23.  The revenue from clients in the fossil fuels industry represented 3.6% in FY 22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemneted Management Practices	The company is committed to stop working with organizations who operate in controversial aspects of controversial industries within the next 5 years.
