



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

IMPLEMENTED MGT PRACTICES	"Siponey complies with all regulations and laws related to the sale of alcohol and has never been cited for any violations of alcohol related laws. The company ensures that all employees involved in the sale of alcohol follow all alcohol related laws and mitigate potential risks through the following actions: - All employees involved in the sale of alcohol are required to obtain a solicitor's license in the state in which they are selling alcohol. - Company is an awarded member of the Distilled Spirits Council (DISCUS) an industry-standard organization that is considered a proponent of Responsible Practices for Beverage Alcohol Advertising. - The company is in compliance with all legal messaging across all of their communication, which include acceptable variations of "please drink responsibly" / "21+ older" / "leader drinking age only". - Siponey also mitigates the risks of potential sales by going above and beyond the TTB regulations for marketing. As an example, the company does not advertise on TikTok due to the lack of control on what ages would see their potential advertisements. - These principles are shared with all partners and consultants of Siponey via their leadership team and largely led by the CEO."
