<b>Summary of Issue</b>	<p>Bonduelle Americas US is part of Bonduelle, a fresh, frozen, and canned vegetable multinational company. Bonduelle Americas US achieved independent certification with one assessment that includes:</p> <ul style="list-style-type: none"><li>1- One (1) commercial office.</li><li>2- Three (3) factories.</li><li>2- One (1) warehouse and distribution center.</li></ul> <p>As a company that manages agricultural and industrial processes, Bonduelle Americas US operates in an industry in which biodiversity impact is a material environmental issue due to its dependency on agricultural input.</p> <p>The company's main agricultural suppliers are located in California and Arizona.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	Approximately 37 % of the company's purchases are agricultural raw materials.
<b>Impact on Stakeholders</b>	Conventional agriculture poses a risk to local ecosystems of flora and fauna, as well as the potential degradation of cultivated land.
<b>Implemented Management Practices</b>	<ul style="list-style-type: none"><li>• The company does not set specific targets for biodiversity preservation or conservation within its local supply chain. However, at the beginning of each commercial relationship with farms, a document outlining best practices for environmental and biodiversity protection is shared with farmers' suppliers.</li><li>• Bonduelle Americas US requires its growers to complete a questionnaire providing key data on farming practices, integrated pest management, health &amp; safety processes, and human rights policies.</li><li>• Bonduelle Group has a target to have 100% of its cultivated area using pollinator protection plans by 2030.</li></ul>

<b>Issue Date</b>	On-going
<b>Topic</b>	Energy Intensive Industries
<b>Summary of Issue</b>	<p>Bonduelle Americas US is part of Bonduelle, a fresh, frozen, and canned vegetable multinational company. Bonduelle Americas US achieved independent certification with one assessment that includes:</p> <ul style="list-style-type: none"><li>1- One (1) commercial office.</li><li>2- Three (3) factories.</li><li>2- One (1) warehouse and distribution center.</li></ul> <p>As a company that manages agricultural input and industrial processes, Bonduelle Americas US operates in an industry in which energy use is a material environmental issue due to its manufacturing processes.</p> <p>Bonduelle Americas US utilizes a combination of electricity and natural gas for heating purposes as energy sources. The breakdown is 72% electricity from the grid and 28% natural gas.</p> <p>The company's primary contributors to its GHG emissions are Scope 3 emissions derived from agricultural inputs. Scope 1 and Scope 2 emissions are emissions from industrial operations and electricity use, while Scope 3 encompasses emissions from product end-of-life, upstream agriculture, packaging, suppliers etc.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	<p>In the last fiscal year, 2023/2024, 100% of Bonduelle Americas US's revenue was earned from the sale of its food products. Bonduelle Americas US's manufacturing facility has an energy intensity of 595kWh per metric tonne of finished product for its standard manufacturing processes in the last fiscal year.</p>
<b>Impact on Stakeholders</b>	<p>Energy-intensive activities, such as manufacturing, pose an environmental risk due to the related emissions derived from energy use.</p>

	The extent of environmental impact is dependent on the energy sources utilised and the management practices in place to manage energy use.
<b>Implemented Management Practices</b>	<p>Bonduelle is committed to near-term science-based targets (SBTi) for carbon reduction, and its detailed carbon intensity data is aligned with these targets, in order to meet its sustainability goals (more details in the company's Sustainability report linked below).</p> <p>Each site has specific energy targets aligned with its overall carbon reduction trajectory. In addition, the company has dedicated energy managers responsible for implementing action plans and investing in energy efficiency projects, often supported by public funding. Bonduelle has a reduction target of 38% Scopes 1 and 2 greenhouse gas (GHG) emissions by 2035 (absolute), which is validated by SBTi.</p> <p>Bonduelle Americas US has invested in a live consumption tracking software, Panoramic Power Radar. It enables, thanks to meters installed all over the facilities, to track live electricity consumption in different areas, generate regular and ad-hoc reports, and set up trigger alerts in case of localized over-consumption. Energy consumption data are tracked and reviewed regularly by dedicated personnel at each production site and through EMS committees/meetings.</p> <p>As of now, Bonduelle Americas US has not conducted any benchmarking assessments to evaluate its energy usage or management performance in comparison to others in the sector. At the group level, a Metrio report is prepared by the global team, which compiles energy rate data from different factories.</p>

<b>Issue Date</b>	On-going
<b>Topic</b>	Water Intensive Industries
<b>Summary of Issue</b>	<p>Bonduelle Americas US is part of Bonduelle, a fresh, frozen, and canned vegetable multinational company. Bonduelle Americas US achieved independent certification with one assessment that includes:</p> <ul style="list-style-type: none"><li>1- One (1) commercial office.</li><li>2- Three (3) factories.</li><li>2- One (1) warehouse and distribution center.</li></ul> <p>As a company that manages agricultural and industrial processes, Bonduelle Americas US operates in an industry that is recognized as a water-intensive industry due to its manufacturing processes.</p> <p>At Bonduelle Americas US, water serves as a key component of our manufacturing processes, in particular to wash lettuce and leafy greens, and for facilities' sanitation.</p> <p>The company's manufacturing sites use water from the municipal network provider. Out of the three (3) manufacturing sites, two (2) are located in an area with low-stress water stress, and one factory is located in an area of high-water stress.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	<p>In the previous fiscal year, 100% of the company's revenue was earned from the sale of its food products.</p> <p>Bonduelle Americas US determined its specific water intensity to be 10.7 L/kg in the previous fiscal year.</p>
<b>Impact on Stakeholders</b>	<p>As a water-intensive industry, agricultural and industrial processes pose risks such as water stress or depletion of local water sources if the water used is not appropriately managed.</p> <p>Bonduelle Americas US primarily uses municipal water sourced from local providers for its manufacturing process.</p>

	The main stakeholders affected are other water users in the regions of operation, such as local water authorities & regulators, residents, other industrial plants, farmers, and the local biodiversity.
<b>Implemented Management Practices</b>	<p>To manage their water intensity, the company has set reduction targets at both the group and entity levels (see CSR report link below for more details). Specifically, the group aims for a 30% reduction in water usage at the group level by 2035 compared to 2020 levels.</p> <p>Bonduelle Americas US has set a target to reduce its water intensity by 10% by 2035. To support reduction efforts, Bonduelle Americas US has invested in a live consumption tracking software, Panoramic Power Radar. Thanks to meters located all around the different areas of each plant, it provides a mapping of water usage to better monitor and control consumption, and identify opportunities for efficiency. Based on findings, efficiency projects have been implemented as well as awareness actions.</p> <p>As of now, Bonduelle Americas US has not conducted any benchmarking assessments to evaluate its water usage or management performance in comparison to others in the sector. At the group level, a Metrio report is prepared by the global team, which compiles water usage data from different factories.</p>

<b>Issue Date</b>	March 2022 and July 2022
<b>Topic</b>	Accidental discharge of water with sugar and anhydrous ammonia from production facilities
<b>Summary of Issue</b>	<p>Bonduelle Americas US is part of Bonduelle, a fresh, frozen, and canned vegetable multinational company. Bonduelle Americas US achieved independent certification with one assessment that includes:</p> <ul style="list-style-type: none"><li>1- One (1) commercial office.</li><li>2- Three (3) factories.</li><li>2- One (1) warehouse and distribution center.</li></ul> <p>Bonduelle Fresh Americas experienced two accidental discharges in the last five years.</p> <p><b>Discharge #1</b> In March 2022, the sugar content from the Apple water changed the chemical oxygen demand (COD) level from the water sample that was pulled by the township. The company exceeded its PH limit. This implied a fine determined by the New Jersey Department of Environmental Protection, responsible for Water Resource Management.</p> <p><b>Discharge #2</b> In July 2022, anhydrous ammonia was discharged on the exterior (environment) of the Irwindale facility (Condenser #3). The issue was flagged by the California Environmental Protection Agency.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	<p><b>Discharge #1</b> The discharge of water happened in the Apple Room at the Swedesboro facility, where the warehouse and distribution center are located. The facility represents around 8% of sq ft of all facilities.</p> <p><b>Discharge #2</b> The discharge on air occurred at the exterior of Irwindale facility</p>

	(Condenser #3), where the commercial office and one factory are located. The facility represents around 60% of sq ft of all facilities.
<b>Impact on Stakeholders</b>	<p>Industrial discharges on the environment may have negative effects on the environment. Both cases resulted in temporary harm that could be addressed with corrective actions and did not require remediation.</p> <p><b>Discharge #1</b> Even though the discharge altered the COD level and the PH limit was exceeded, there were no harms reported to workers or the environment.</p> <p><b>Discharge #2</b> According to the U.S Environmental Protection Agency, anhydrous ammonia can cause serious, often irreversible health effects when released. In addition to potentially harmful effects from inhalation or skin contact with this substance, it is highly flammable. Anhydrous ammonia is considered an extremely hazardous substance. There were no impacts on the community or the environment based on the location of the site.</p>
<b>Resolution</b>	<p><b>Discharge #1</b> The company had to pay a fine of \$ 1,000 defined by the New Jersey Department of Environmental Protection.</p> <p><b>Discharge #2</b> No fines issues yet. The incident is under the EPA's review.</p>
<b>Implemented Management Practices</b>	<p><b>Discharge #1</b> The company paid the fine and implemented a process to capture the residue of Apple Water, which is constantly monitored.</p> <p><b>Discharge #2</b> The company replaced the condenser, reviewed the routine pH checks, and frequently monitors ammonia levels, and enhanced preventative measures.</p>

<b>Topic</b>	Litigations related to labor, contract disputes, and corporate liability.
<b>Summary of Issue</b>	<p>Bonduelle Americas US is part of Bonduelle, a fresh, frozen, and canned vegetable multinational company. Bonduelle Americas US achieved independent certification with one assessment that includes:</p> <ul style="list-style-type: none"><li>1- One (1) commercial office.</li><li>2- Three (3) factories.</li><li>2- One (1) warehouse and distribution center.</li></ul> <p>Bonduelle Fresh Americas has several labor litigations (~25) related to employment violations and claims (discrimination, harassment, retaliation, wrongful termination, whistleblowing retaliation), in addition to two (2) class action labor cases related to wage and hour disputes. One case relates to the lack of specific technical information on employees' pay statements, and the other one relates to overtime, meal, and break requirements.</p> <p>Furthermore, the company has experienced one litigation related to a contract dispute with a supplier and a few scattered cases related to corporate liability from auto accidents.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	<p>The class action cases represent a significant number of stakeholders (workers), while the other cases represent individuals.</p> <p>All cases together represent a financial liability between 1%-3% of the company's revenues.</p>
<b>Impact on Stakeholders</b>	<p>The main stakeholders affected depend on the case topic. Cases related to the labor topic affect the company's own workforce, who allegedly suffered financial, emotional, and legal/reputational harm.</p>
<b>Resolution</b>	<ul style="list-style-type: none"><li>• The two class action labor cases were settled with payment.</li><li>• The labor cases related to employment violations and claims have a mix of resolutions, including settlements</li></ul>

	<p>with payment, ongoing, and pending status.</p> <ul style="list-style-type: none"> <li>• The contract dispute case was settled with payment.</li> <li>• The corporate liability cases linked to auto accidents are pending.</li> </ul>
<b>Implemented Management Practices</b>	<p>To avoid the recurrence of labor issues and complaints, the company retained outside counsel to conduct a thorough review of all wage and hour policies, developed a process for periodic wage and hour audits, and provided additional training on requirements to both management and hourly employees.</p> <p>Furthermore, the company has implemented periodic formal and informal training for the human resources team related to discrimination and the requirements of the interactive process, and revised interactive processes and forms.</p>

<b>Summary of Issue</b>	<p>Bonduelle Americas US is part of Bonduelle, a fresh, frozen, and canned vegetable multinational company. Bonduelle Americas US achieved independent certification with one assessment that includes:</p> <ul style="list-style-type: none"><li>1- One (1) commercial office.</li><li>2- Three (3) factories.</li><li>2- One (1) warehouse and distribution center.</li></ul> <p>The company has had 4 recalls in the last five years due to quality control issues.</p> <p>Recall #1 (February 2020) - An incorrect bottom label on the Bistro® Bowl Spinach Dijon Salad.</p> <p>Recall #2 (September 2021 )- Recall due to a labeling error from the supplier leading to the presence of an undeclared allergen (anchovies) on the dressing.</p> <p>Recall #3 (February 2024)- A supplier voluntarily recalled its dairy products due to the potential contamination with Listeria monocytogenes. As a supplier of Bonduelle Americas, Bonduelle Americas proceeded with the voluntary recall of products that contained cheese from this supplier.</p> <p>Recall #4 (October 2024)- A supplier recalled ready-to-eat (RTE) meat and poultry products due to the potential contamination with Listeria monocytogenes. As a supplier of Bonduelle Americas, Bonduelle Americas proceeded with the voluntary recall of products that contained RTE meat and poultry from this supplier.</p>
<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	The recalls represented less than 1% of Bonduelle Americas US's production in the respective fiscal year.
<b>Impact on Stakeholders</b>	<p>The product recalls carried risks for consumer contamination and allergies.</p> <p>Food recalls related to quality and safety impose risks and may harm consumers physically, economically, and emotionally.</p>



<b>Resolution</b>	<p>The company received consumer claims related to the Listeria contamination, including complaints that consumers suffered illnesses from consuming allegedly contaminated products.</p> <p>The claims were resolved through the company's processes without any litigation.</p>

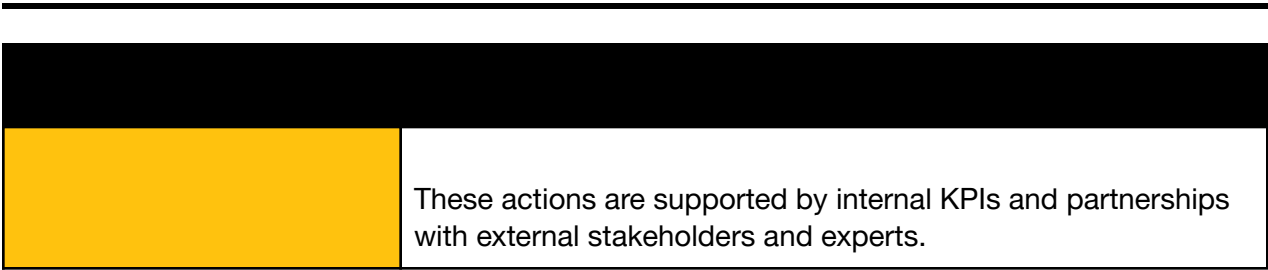

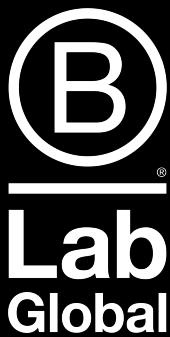

<b>Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)</b>	<p>In the previous fiscal year, 100% of the company's revenue was earned from the sale of water intensive food products.</p> <p>On average, Bonduelle uses 13 liters of water to make one kilo of finished product.</p>
<b>Impact on Stakeholders</b>	<p>Water intensive industries poses risks such as water stress or depletion of local water sources if water use is not appropriately managed.</p> <p>Bonduelle Germany's water sources are 100% from tap water. The sites and their wider surroundings are not threatened by water shortages.</p>
<b>Implemented Management Practices</b>	<p>Bonduelle Group has integrated water management into its new environmental management system. Bonduelle's plants self-assess their industrial processes. The group has chosen an approach by business unit: each sets its reduction target and its roadmap with regard to the overall objective for the industrial scope (-30% by 2035). Bonduelle Germany has set a target of -2.5% in FY24/25, -25% in FY34/35); a target which is monitored on a monthly basis.</p> <p>The group conducts their Energy and Water Management Network annually, carrying out an assessment on various topics including water consumption and management. Fresh factories are compared to each other and ideas are exchanged in their meeting every 6 weeks.</p>

	<p>The two plants run by Bonduelle Germany are continuously implementing targeted action plans:</p> <ul style="list-style-type: none"> <li>- The consumption of the corresponding meters in the Reutlingen plant is automatically recorded and reported. The introduction of this system in the Straelen plant is being developed;</li> <li>- Monitoring performance indicators and water losses;</li> <li>- Installation of equipment to control and manage consumption;</li> <li>- Water recirculation loop processes for cooling canned food;</li> <li>- A detailed and close-meshed consumption monitoring (hourly, daily, weekly and monthly, separated into fresh and ice water, per production line).</li> <li>- Implementation of standard monitoring of the machines in order to check deviations from the targets and to take immediate corrective action (per line on shift level).</li> <li>- Long-term efforts to increase sensitivity of employees with regards to water losses, leading to quick response of employees in the event of problems, to avoid significant losses.</li> <li>- Water dosage in the washing lines during production adapted to the flow (if the line stops, the water supply is cut off) and the reuse of water (in the 1st washbasin ice water is reused from the washbasin No. 2, 1.5-1.8 m3 per hour) during the washing process.</li> <li>- In addition, the company has implemented low-flow faucets, water-saving faucets, toilets, etc. in all areas (including the central office).</li> <li>- In the "water maturity grid" the company defines annually the most important areas of action in order to achieve the set goals (country and group goals). The action plans derived from this are incorporated into the annual budget planning process.</li> <li>- Frequency of Water exchange rates due to water turbidity project scheduled to be finished by end of 2024 which could be responsible for a reduction of 20% in water consumption.</li> </ul> <p>At a group level, some plants have carried out testing of more efficient water consumption technologies such as water reuse for some processes, which will be rolled out on a larger scale if they prove successful.</p>
