TOPIC	Potential pollution of the Maltorne River
SUMMARY OF ISSUE	The main negative impacts of the company are the potential pollution of the Maltorne by livestock effluents related to the storage of the latter (small river working on the farm) and the amount of effluent spread in the fields.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Low impact on affected individuals (\$ 0) Strong impact on the environment if release of uncontrolled toxic material but low risk (difficult to figure because it has never happened to date).
IMPACT ON STAKEHOLDER(S)	Impact on the visibility of the company as a polish if rejection in the river and some of our stakeholders might not want to be associated with this pollution
RESOLUTION	The farm has put in place valve closing systems for all pipes going to the river. All livestock effluents are contained in a defined area with safety flanges. An alarm reported on 5 phones is triggered in case of risk of discharge into the river, it immediately triggers an intervention of trained personnel of the company and the mobilisation of intervention equipment.
IMPLEMENTED MGT PRACTICES	To avoid the pollution of the river we have set up an agricultural biogas to move the storage of livestock effluents in a secure area far from the river (next to biogas plant). For the spreading, a preliminary assessment of manure is carried out each year according to the analyzes of soils, the needs of the culture, the analyzes of the natural fertilizer (our digestate) and the maximum authorized regulatory threshold in France (BIO).
REPORT	Every exercise, procedure modification or risk is recorded and shared with the employees of the company. These elements are then discussed in management review.
OTHER MANAGEMENT COMMENTS	ISO 14001 certification is part of an approach to anticipate problems. Each audit makes it possible to redo a point on the good knowledge of the procedures to avoid any rejection in the river.
