Sustainable Investing at radicant: Here we have developed our proprietary SDG Impact Rating, which assesses the impact of companies based on their operations, products and services. We assess this impact (negative and positive) across all individual SDGs. As a result, we only invest in companies that have a net positive impact (>20 on a scale from -100 to +100). Whether a company has a positive impact on a specific SDG depends on its business model. For our investment funds we consider all SDGs, for our thematic investment themes we consider one to three SDGs and accordingly the invested companies have to have a specific 'SDG flag'.
