Summary of Issue	Hyphenate Ltd is a salesforce partner that has had clients in the Charity lotteries and Nuclear Power or Hazardous Materials industry. The nature of the company's services with clients in these industries has been related to consulting and software implementation, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients operating in the Charity lotteries industry represented 1.01% in FY22-23. The revenue from clients operating in the Nuclear Power or Hazardous Materials industry represented 1.16% in FY22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have any positions on working with clients in sensitive industries.
	The company assesses the ethics of their clients business practices before agreeing to work with them. All their clients in controversial industries and 99% of their revenues are from non-profit organizations. The company learns about their operations during our pre-sales and discovery processes
